Dersin Tanımı	COURSE DESCRIPTION The aim of this course is to demonstrate the fundamentals of EU competition policy, which is one of the most important Community policies. It is not only important because it has an enormous proportion of cases before the Court of Justice, but also because it involves economic, financial and intellectual interests. Firstly, the meaning of competition, such as perfect competition and workable competition will be made clear, together with an explanation why there is a need of a regulation and a policy of competition. Then the Articles 101 and 102 of the EU Treaty concerning the regulation of competition will be explored in depth. Agreements, decisions and concerted practices between undertakings, which prevent, restrict or distort competition within the EU will be examined. Distributorship, licensing and franchising agreements will be looked at. The exemption procedure will be explored together with the different types of Block Exemptions. Then the concept of dominance in the market and which practices can be defined as abuses of dominant position will be examined. Regarding the policy rules, together with the theoretical background example case law will elaborate the comprehension of the subject matter. LEARNING OUTCOME I Student will learn sources of EU Competition Law and their application methods. I Student will learn basic prohibition of EU Competition Law and its rules of procedure. I Student will learn penal sanctions of EU Competition Law and their determination and application process. I Student will internalize European Union system in a manner that relations between industry and competition are more easily perceived among member states of European Union.
